- 20 Cases Per Month Program-27" Refrigerated Counter-Top Case:** This program requires a rolling 12-month average of 20 cases per month over a 2-year commitment. After the initial 2-year period the display case becomes the property of the customer (*brand, model and size subject to change based on availability*):



- 40 Cases Per Month Program-48" Refrigerated Case:** This program requires a rolling 12-month average of 40 cases per month over a 2-year commitment.
